Thanks for the great meeting today to discuss Trump Proof Seattle's proposal to tax the rich to pay for indispensable city services. As offered at the meeting, I am attaching this work in progress of the ordinance language I have been writing for Kshama. I have drawn some of the language from the Opportunities for Olympia initiative, some from other City's tax code, and a lot from the Seattle Municipal Code language particularly Chapter 5.55. I'll send you all new drafts as they come up. As we discussed in the meeting, the process of drafting, has brought up for me a lot of administrative questions that I never considered. Note the track changes comments I put in the margins to see some of those administrative questions.

Finally, as we discussed at the meeting, please let me know the time and place for the upcoming meeting with Greg (cc'd here) so I can join you there.
